#### **As per the nomination requirements from Article 6 of the MNO Electoral Code: Part A, I declare that:**

- I have not been convicted, within the past five years, in connection with an Election, of corrupt practice, accepting a bribe, dishonesty or malfeasance;
- I have not had my rights or privileges as an MNO citizen suspended by the PCMNO pursuant to the MNO Electoral Code: Part A, the MNO Policy – Conditions or Limitations that May Apply to MNO Citizenship, or the MNO Bylaws; and
- I have read the Métis Nation of Ontario Electoral Code: Part A, the MNO Bylaws and the Métis Nation of Ontario Veterans Council Charter Agreement.

#### **Further, as per Article 6.4 of the MNO Electoral Code: Part A, I solemnly affirm that:**

I affirm that I do not identify as Indian or as Inuit and I am not registered as an Indian under either the Indian Act or any band membership code or as an Inuk under an Inuit Registry.
