**Exhibitor Standards and Cancellations:**

The MNO reserves the right to establish minimum display standards and to accept or reject trade show applications without stated cause. There is in effect a NO CANCELLATION – NO REFUND POLICY for cancelled space. There will be no sub-letting of booth space. The MNO reserves the right to cancel a contract with a potential exhibitor upon written notice, provided such notice is given five days prior to the tradeshow. As children may be in attendance, the MNO reserves the right to cancel a contract with same day notice should the content of displays or items being sold or presented be inappropriate for all age groups.

**Cultural Booths:**

Individuals and groups wishing to display cultural information and/or distribute cultural items at no cost to Annual General Assembly participants are eligible to display space as a Cultural Booth. Individuals and groups operating Cultural Booths are not permitted to sell anything at their booths. There is no cost for a Cultural Booth but a \$100 deposit must be paid. The deposit will be returned after the AGA providing the operator did not attempt to sell any items through the Cultural Booth.

**Exhibitor Insurance:**

It's essential that every exhibitor meet all fire, health and any other related provincial regulations. Liability, public liability, theft, fire and other insurance coverage is required and such insurance is your responsibility. The Métis Nation of Ontario will require you to sign this waiver releasing the MNO from responsibility.
