April 29, 2026

By motion of the Provisional Council of the Métis Nation of Ontario (PCMNO), I was appointed as the Electoral Officer to oversee the Moon River Métis Council election scheduled for April 27-29, 2026.

My responsibilities included conducting and supervising all aspects of the election process, ensuring impartiality, and taking all necessary actions to facilitate a fair election in accordance with the Moon River Métis Council Electoral Code.

There are ten (10) positions on the council. Following the close of nominations on April 7, 2026, nineteen (19) nominations were received. All candidates were verified. One (1) nomination was disqualified. Four (4) positions were acclaimed (uncontested). One (1) verified candidate withdrew. Pursuant to Article B33.1 of the Moon River Métis Community Council Electoral Code, it is my duty to announce the election results and declare the following candidates elected to a four (4)-year term:
